



Quarterly Fund Commentary

- The Fund's investments in, and underweight exposure to, the financials sector contributed to relative performance, as did its investments in the utilities sector.
- In financials, an investment in TMX Group and lack of exposure to a Canadian bank contributed to relative returns. In utilities, an investment in Fortis and out-of-benchmark exposure to Veolia Environnement contributed to relative returns. In other sectors, investments in Agnico Eagle Mines and Franco-Nevada contributed.
- The Fund's investments in the industrials sector detracted from relative performance, as did its investments in, and underweight exposure to, the materials sector.
- In industrials, investments in TFI International and AtkinsRéalis Group detracted from relative returns. In materials, lack of exposure to a Canadian multinational precious metals streaming company and a Canadian gold mining company detracted from relative returns. In other sectors, investments in Rogers Communications and Alimentation Couche-Tard detracted.

12 Month Fund Commentary

- The Fund's investments in the information technology sector detracted from relative performance. Its investments in, and overweight exposure to, the
 consumer staples sector also detracted.
- In information technology, underweight exposure to Shopify and an investment in Lightspeed Commerce detracted from relative returns. In consumer staples, an investment in Alimentation Couche-Tard and out-of-benchmark exposure to Dollar Tree detracted from relative returns. In other sectors, an investment in Rogers Communications and lack of exposure to a Canadian multinational precious metals streaming company detracted.
- The Fund's investments in the consumer discretionary and financials sectors contributed to relative performance.
- In consumer discretionary, an out-of-benchmark investment in Park Lawn and an investment in Magna International contributed to relative returns. In financials, investments in TMX Group and Fairfax Financial Holdings contributed to relative returns. In other sectors, investments in Agnico Eagle Mines and Canadian Pacific Kansas City contributed.

Positioning and Outlook

- At the end of the quarter, the Fund had its largest overweight exposures to the consumer staples and industrials sectors. The financials and energy
 sectors accounted for the Fund's largest underweight exposures. In absolute terms, financials and industrials accounted for the Fund's largest
 exposures while health care and real estate accounted for the least absolute exposure.
- Canadian equity markets entered 2025 with heightened uncertainty as shifting trade policies, rising tariff threats and evolving monetary signals
 continued to challenge investor expectations. Against this complex backdrop, portfolio manager Max Lemieux remains focused on uncovering
 opportunities in businesses with strong fundamentals, resilient balance sheets and long-term earnings visibility. While short-term volatility remains
 elevated, Max believes it also creates compelling entry points in select areas of the Canadian equity market, particularly where valuations have become
 dislocated from underlying fundamentals.
- In this evolving environment, Max continues to take a measured and selective approach, identifying long-term opportunities while remaining mindful of policy shifts particularly the re-emergence of tariffs under the new U.S. administration. The manager acknowledges that these risks are difficult to predict, but emphasizes that they can also create entry points in high-quality businesses with strong fundamentals and durable cash flows. Areas such as gold have proven helpful from a diversification and thematic perspective, especially as investors grow more focused on inflation hedges and the geopolitical value of resource exposure.
- In terms of positioning, the portfolio manager continues to emphasize companies with resilient balance sheets and pricing power. Defensive holdings such as grocers and consumer staples, while not immune to headwinds, are viewed as anchors, particularly when complemented by more opportunistic exposures. Max also sees selective upside in beaten-down names where fundamental quality remains intact, citing recent activity in high-conviction ideas that have corrected on short-term news or cyclical concerns.
- From a macroeconomic standpoint, the manager is carefully monitoring the Canadian dollar, inflation trends and the potential for increased fiscal spending particularly as the federal election approaches. While recession and stagflation risks are widely discussed, the manager does not believe these risks are uniformly priced across sectors. Selective exposure to more insulated business models and underappreciated Canadian exporters offers a potential offset.
- Overall, Max believes the current environment demands agility and conviction. Although the landscape is shifting rapidly, the Fund remains positioned
 to take advantage of volatility and emerging dislocations, with a long-term focus rooted in bottom-up research and a cautious approach to risk
 management.



Investment Process

Sources of information and investment ideas

Notes from Team Canada analysts, meetings with company management, conferences and third party research and publications

Investment style and portfolio construction

- Bottom-up, fundamental company analysis is the primary driver of portfolio construction
- Stock selection is driven by a growth at a reasonable price (GARP) approach, with an absolute return bias and strong focus on mitigating downside risk during periods of market weakness
- Looks for companies that are expanding margins and driving earnings-per-share growth, through prudent cost management and growing top line
 revenue
- Valuation analysis includes absolute versus relative to peers and industry, Price/Earnings, FCF yield, EV/Sales, PEG emphasis for faster growing
 industries such as technology or biotech, EV/EBITDA
- Highly values management quality and experience
- Looks for stocks that will outperform the market and peers over the next 12-18 months
- May invest in restructuring stories if valuations are sufficiently attractive and the outcome of restructuring has the potential to unlock significant value
- Insensitive to benchmark composition
- Sector weights result from bottom up stock selection, while industry selection is informed by both bottom-up and top down considerations
- Position size a function of conviction, may concentrate up to 5-7% of the portfolio in a single stock
- May hold core long-term positions in the portfolio and may trade around these opportunistically
- Buys/sells purely a function of relative valuation and company fundamentals
- May invest in non-Canadian stocks up to 30% but allocations to foreign stocks will typically average 10% or lower
- Will typically hold 3-5% in cash, however, in certain market conditions, may hold cash balances between 0-20%

Risk control

- Constantly searching for stocks offering the best risk/ reward profile (upside/downside potential)
- Thoroughness of analysis is the key risk control measure
- Manager runs diversified portfolio, typically less than 100 names, but willing to have significant under/overweights at stock or sector level
- · Shifts portfolio beta based on market environment and whether market will pay for taking on a higher level of stock or portfolio risk
